

## ANNOUNCEMENT OF SUBSTANTIAL SHAREHOLDINGS

(“Cox Energy”, “the Issuer” or “the Company”) (BIVA/BMV: COXA\*, BME: COX), a utility company dedicated to the development, construction, and management of energy generation projects with presence in America, Europe, Africa, and the Middle East, informs its shareholders and the general investor public that, under the provision of Article 17 of Regulation (EU) n° 596/2014 on market abuse and Article 227 of the Law 6/2023, of March 17, on Securities Markets and Investment Services, and related provisions, as well as Circular 3/2020 of the BME Growth segment of the BME MTF Equity, Cox Energy, S. A.B. de C.V. (the “Company”), the following relevant information:

Enrique Riquelme Vives' total stake in the share capital of Cox Energy Solar, S.A. is 64,5%, with his indirect participation in the Issuer's capital being 52,0%.

The Company is not aware of any other shareholders holding a direct or indirect stake exceeding 5%.
