

## SUBSTANTIAL SHAREHOLDINGS

**Madrid, January 10, 2025 – COX ENERGY, S.A.B. DE C.V. (“Cox Energy”, the “Issuer” or the “Company”)** (BIVA/BMV: COXA\*, BME: COXE), a vertically integrated utility, leader in energy generation, transmission, and commercialization, covering the entire value chain from plant development to self-consumption with a presence in the Americas, Europe, Africa, and the Middle East, and in accordance with Article 17 of Regulation (EU) No. 596/2014 on market abuse and Article 227 of Law 6/2023, dated March 17, on Securities Markets and Investment Services, and related provisions, as well as Circular 3/2020 of the BME Growth segment of BME MTF Equity, the Company provides the following key information:

1) Mr. Riquelme Vives holds a majority stake in the capital of Inversiones Riquelme Vives, S.L., and a 100.0% stake in Lusaka Investments S.L. and Riquelme Capital Group, S.A. These companies hold stakes of 59.9%, 3.9%, and 1.3% in the capital of Cox ABG Group, S.A. (formerly Cox Energy Solar, S.A.). Enrique Riquelme Vives' total stake in the capital of Cox ABG Group, S.A. amounts to 65.1%, with his indirect stake in the Issuer's capital being 48.4%.

The Company has no knowledge of other shareholders holding a direct or indirect stake exceeding 5%.

In accordance with Circular 3/2020 of the BME Growth segment, it is noted that the information provided in this document has been prepared exclusively by the Company and its administrators.
